



INCOME WITHHOLDING MODIFICATION ORDER

On this 1st day of April, 19 91,
IT IS ORDERED THAT the above named employer/payor shall:

- 1. Modify the amount of the judgment debtor's income withholding as follows:
 - \$ 375.00 semi-month per/ ~~month~~ for current support only.
 - \$ _____ of the debtor's monthly disposable income to satisfy past due amounts only, or
 - \$ _____ of the debtor's monthly disposable income to satisfy current support and past due amounts, plus _____% of disposable income to apply to arrearages; the total sum to be withheld not to exceed 55% of monthly disposable income. (Current support is \$ _____ per month.)
- 2. Ensure that the total withheld from disposable income is not more than: (circle one)
 - 50% 55% 60% 65%
- 3. Return a completed copy of the worksheet to the Court.
- 4. Be notified of the rights and duties of an employer/payor as stated on the attached forms which are incorporated in this order by reference.
- 5. Your payment must identify your employee by name and this court case by number. Your payment must be sent and made payable to:

- 4. TERMINATE the withholding of income completely.

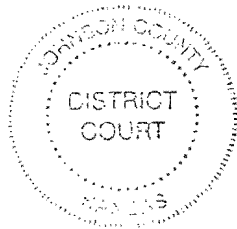

MOTION AND AFFIDAVIT FOR ORDER TO APPEAR


The Court Trustee states:

3. That DANIEL D. PHILLIPS is now delinquent in the sum of \$9,779.00.


4. That DANIEL D. PHILLIPS has shown no cause on the Court Trustee records for such disobedience of and failure to comply with the orders of the Court.




ORDER TO APPEAR FOR EXPEDITED HEARING
